All in favor, motion carried.</p> <p>Public Hearing Opened at 7:03pm</p> <p>A. Case #2018-1: 818 Miller Rd: Sawicki read an overview of the case as described by the owner. The owner is requesting a variance on a side setback and would like to install a 20 panel solar array that would be 9' wide x 33' and off the ground. The panels will be in 2 rows of 10. They think this is the most viable location. The owners are transitioning some of their 2 acres into a small organic farm.          Two of the neighbor residents attended the meeting to share their concerns. One neighbor lives on the north side of 818 Miller and the other lives on the south side. Both questioned if any trees or bushes would be cut down. After further discussion the neighbors stated they have no issues with the solar panels going up. Moquin made the motion to close the public hearing and Aquinaga seconded.          Closed Public Hearing at 7:21 pm</p> <p>Roll Call: Aquinaga-no. He stated he had concerns about how they would repair the panels – 4' off the property seems to be too close and not enough room to get a tractor or vehicle between that structure. Baranowski-yes. He stated he is in support of the variance and thought it was the most viable area and the fact the neighbors were compliance with it. Miller-no. He stated 4' is too tight.
