Baranowski stated that he would like to see Rachel Reid as Clerk, to which Reid stated she was not interested in the position. Rushing motioned to appoint Dawn Behem as Clerk, seconded by Titus. Discussion then took place regarding how not having a Clerk will affect the township. Titus stated that if no one was appointed within 45 days, then the county will step in and conduct a special election to fill the position.
