Supervisor's Announcement: Al Titus announced the purpose of the Annual Meeting and explained the Electors role in this meeting. Thanked Clerk Behem for her hard work on securing ARPA Funding for the township that will be used to expand the work done on our roadways, install generator systems at the township office and hall locations, replace the township office roof and update the township website. The annual road trip with the county road commission was held to assess limestone areas of need and will be out again to look at troubled areas for ditching next week. Road work will begin when weather conditions allow. County ARPA funds for approved road work projects will be reimbursed once the projects are completed. The Community Foundation approved a \$12,000 Parks & Rec grant for improvements. Blight remains an issue of concern and need to get a better handle on both old and new problems.
