Work started without a permit subject to additional fees.</p> <p>Expiration of permit: A permit shall become invalid if the authorized work is not commenced or completed within six (6) months after issuance of permit. A PERMIT WILL BE CLOSED WHEN NO INSPECTIONS ARE REQUESTED OR CONDUCTED WITHIN SIX (6) MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CLOSED PERMITS CANNOT BE REFUNDED. THE CHARGE TO EXTEND A PERMIT IS \$75.00. ONLY with board approval. WORK STARTED WITHOUT A PERMIT IS \$100.</p> <p>Calling for inspections: When ready for an inspection, call the inspector providing as much advance notice as possible. The inspector will need the permit number, job location, access information and telephone number.</p> |
